**BID CLARIFICATIONS, ADDENDA, and INTERPRETATIONS:** Bidders shall promptly notify the University of any ambiguity, inconsistency, or error which they may discover upon examination of the plans, specifications, or other contract documents.

Any and all interpretations of the drawings, specifications, Responses to any RFIs, or other contract documents and any supplemental instructions, will be in the form of a written bid clarification/addendum, if issued, and will be posted as part of the HuskyBuy ITB sourcing event under the Buyer Attachment Tab. Failure of any Bidder to receive any such addendum or interpretation shall not release any Bidder from any obligations under its bid as submitted.

These guidelines establish consistent standards for mitigating the spread of COVID-19 that must be undertaken by the Contractor and are intended to assist UConn in meeting its commitments.

**PROJECT DESCRIPTION/SCOPE OF WORK:** The University is engaged in a multi-year project to upgrade its network equipment and wired access infrastructure to the current standards. As part of this effort this coming summer two academic complexes need upgrading:

Hartford School of Law:

1. Hosmer Hall - Site of faculty offices, the Insurance Law Center, and Janet M. Blumberg Hall, where many law school events are held.

2. Knight Hall - Site of faculty offices, the Insurance Law Center, and Janet M. Blumberg Hall, where many law school events are held.

Scope of Work:

Base Bid:

Hosmer Hall – The Building will require replacing existing cable wiring. Currently there are multiple telecom rooms that will be condensed into one expanded TR Room TR113 on the 1st Floor. TR113 will be expanded into a with the assistance of UConn Facilities – FO Department. Hosmer Hall Building characteristics:

- Hartford Law School Campus Hosmer Hall
  - (4) floors: Basement, First, Second floors and 3rd Floors.
  - (1) Existing TR113 on the 1st floor will be expanded with assistance from UConn Facilities-FO.

## Alternate #3:

Knight Hall – The Building will require replacing existing cable wiring. The current telecom room 005 will be expanded into TR Room 003 by installing to support copper and fiber backbones. Knight Building characteristics:

- Hartford Law School Campus Knight Hall
  - (3) floors: Basement, First and Second floors.
  - (1) Existing TR 005 in the basement shall be relocated to new basement TR 003.

## **PROJECT SCHEDULE/DURATION:**

- The construction is planned to start: MAY 15, 2023
- Construction duration: **3 MONTHS**

**LIQUIDATED DAMAGES:** Liquidated Damages of **FIVE HUNDRED DOLLARS** (\$500.00) per calendar day shall be assessed if the Contractor fails to achieve Substantial Completion or causes delay to the Substantial Completion of any portion of the work within the Contract Time.

**WAGE RATES:** Prevailing Wages are required for this Project if the total cost of all work to be performed by Contractor and Subcontractors is \$100,000.00 or more and subject to the provisions of Connecticut General Statutes §31-53, §31-54, and §31-55. Bidders shall review Connecticut General Statutes §31-53, §31-54, and §31-55. **SELF-PERFORMANCE REQUIREMENT:** If awarded this contract, the Contractor on this Project shall be required to perform not less than ten percent (10%) of the completed dollar value of the work with its own forces.

**SET-ASIDE REQUIREMENTS:** The "Set-Aside" Requirement for this Project is that (1) not less than thirty percent (30%) of the Total Contract Price be awarded to subcontractors who are certified by the Connecticut Department of Administrative Services as "Small Business Enterprises" ("SBEs") and (2) not less than ten percent (10%) of the Total Contract Price be awarded to subcontractors who are certified by the Connecticut Department of Administrative Services as "Minority Business Enterprises" ("MBEs") (the 10% set aside for MBEs may be included in the 30% set aside for SBEs). If the Contractor is an S/MBE, then any self-performed work may be included in the Set-Aside Requirement. The Contractor is responsible for ensuring that they, and the S/MBEs they have selected, are eligible Connecticut-certified S/MBE contractors.

The University of Connecticut is committed to increasing participation and enrollment of Small and Minority Businesses (S/MBE's) on our contracts. It is expected that those contracting with us will give thoughtful consideration to the approach they use in their selection of the eligible Connecticut-certified S/MBE's that they will utilize and maximizing work opportunities for S/MBE's.
